Verdict of First Degree Court:	The bankruptcy judge issued a verdict approving the liquidation and the distribution plan. The Bankruptcy Department shall notify both The Bankruptcy Trustees Committee of Investment Dar Company and the Bankruptcy Committee of this verdict. It shall also notify the debtor and creditors by publishing the same in Kuwait's Official Gazette and shall have the verdict endorsed with the executory formula. Furthermore, to mandate the Trustees Committee to submit a monthly statement on the liquidation status, the amounts deposited, and the distributions made to creditors as per the plan.
Verdict of Court of Appeal:	None.

Expected Impact of the court verdict on the Company	<p>The financial impact on the bank cannot be determined at the present time until distributions to creditors are made according to the plan approved by virtue of the bankruptcy judge's verdict.</p> <p>The bank will disclose the receipt of any distributions as per the plan in due course.</p>
