Good morning, everyone, and welcome.

This is Maha Alrefai from Kuwait Investment Company, Investor Relations Unit. We are pleased to welcome you to Kuwait Investment Company's online Analyst Conference for the first quarter of 2026. Joining us today are Mr. Hany Elnowaihy, Chief Financial Officer, and Mr. Faisal Al-Meshari, Deputy CEO of Direct Investments and Corporate Finance Sector.

Today, we will review the Company's financial performance for the first quarter of 2026.

Now, I would like to hand over to Mr. Hany to present the Company's financial results. Please go ahead.

**(Mr. Hany Elnowaihy):**

Thank you Ms. Maha.

Good morning, everyone.

Due to the current circumstances in the Gulf area and the impact on the financial markets regionally and internationally, all players in the finance industry have been impacted due to the current geopolitical tense. Q1, 2026 revenues are KD 4.6 million with a decrease of fifty-one percent, while the expenses are KD 4.6 million with a decrease of four percent. The net loss on a consolidation basis is fifty thousand Kuwaiti dinar. Our assets are KD 327 million compared to KD 323 million, with a growth of 1.5%. The liabilities increased by 11.6%, while the equity decreased, mainly due to the announcement and accrual of dividends. Our general assembly approved 18% cash dividends to our shareholders, KD 9.9 million as an amount, and this is the main reason why equity has decreased.

In the income statement, profit for the shareholders of the parent company is a negative amount of KD 858K compared to net profit of KD 3.8 million. A loss per share of 1.56 Fils, compared to almost seven fils per share profit in the comparative period.

As we mentioned, we have growth in assets compared to December 25 and March 25. Also, the equity attributable to shareholders of KIC is KD 130 million compared to KD 141 million in December and KD 124 million March '25.

Total equity is KD 168 million in March '26 compared to KD 180 million in December 25 and KD 161 million in March '25.
