Material Information	Metal and Recycling Company (K.S.C.P) ("MRC") would like hereby to disclose the issuance of the Disciplinary Board Resolution No. (86/2023 Disciplinary Board) (108/2023 Authority) that imposed a financial penalty against MRC for violating the disclosure and transparency rules. For the following reasons: For violating the following: 1) The provision of item No. (17) of Article (4-1-1) of Module Ten (Disclosure and Transparency) of the Executive Bylaws of Law No. 7 of 2010 and their amendments, which stipulates that: The company did not disclose signing one of the effective financing contracts. 2) Provision of Article (4-2-1) of Module Ten (Disclosure and Transparency) of the Executive Bylaws of Law No. 7 of 2010 and their amendments: Due to the company's delay in disclosing a number of material information. The decision included the imposition of the following penalty: "Imposing a financial penalty on Metal and Recycling Company an amount of KD 1,000 (one thousand dinars) for each of the two violations."
