Parties of the case	Kuwait Automotive Imports Company – Plaintiff. Geely International Corporation Company - China – First Defendant. Ali Mohammed Thunayan Alghanim and Sons Automotive Co. – Subsidiary Company - Defendant. Undersecretary of the Ministry of Commerce and Industry in his capacity - Defendant. Public Authority for Industry – Defendant. General Administration of Customs – Defendant.
The Judgment is in favour of	Kuwaiti Automotive Imports Company. Please note that Geely International Corporation (China) intends to file an appeal against this judgment before the Court of Cassation and will request a stay of execution of the judgment pending the issuance of the Court of Cassation's decision.
The Concluding Judgement of the Court of First Instance	The court ruled to dismissed the claim.
The Concluding Judgement of the Court of Appeal	The Court of Appeal ruled on the appeal by setting aside the appealed judgment and re-adjudicating the case, ordering the First Respondent Company to pay the Appellant the amount of KWD 1,000,000 (one million Kuwaiti Dinars). The Court also ordered the company to bear the legal costs for both levels of litigation and to pay KWD 1,000 as attorneys' fees.
The Concluding Judgement of the Court of Cassation	None.
The potential effect of the Judgement on the company	No significant effect of the material information on the financial position of the company.
